- Inspection fees must be disclosed. Certification Fees: The certification fee shall be comparable to the license fee prescribed in ARS §41-2092.
- Allow you an opportunity to have an authorized on-site representative accompany our representative, except during confidential interviews.
- Provide notice of the right to have: **a.**Copies of any original documents taken from your site or any analysis or samples taken **b.** A split sample of any sample taken.
- Inform you when a conversation is tape-recorded.
- Inform you when pictures are being taken.
- Inform you that any statement made by you or your representative may be included in the inspection report.
- Prior to initiation of an inspection, provide you with a copy of this form.
- Inform you that a copy of the inspection report and related deficiency documents, will be provided at the time of inspection or will be available within 30 days of the inspection date on the web, at <https://dwm.az.gov> home page, under **Online Inspection Search** link (your BMF# is required). The inspection report or related documents shall contain all deficiencies identified during the inspection including statutory, administrative rule or NIST handbook cites.
- Inform you that an e-mail notification of this inspection will be submitted to e-mail address accounts registered in our database under the Business contact information.
- Inform you that a copy of this form will be retained with the associated inspection report per state requirements.
- Inform you that at least once a month following an inspection, which reveals deficiencies and until the department “closes” all related actions, the agency shall update you as to the status of any pending agency actions.
- Inform you that you have the right to appeal an Administrative Order pursuant to A.A.C. R20-2-109. The appeal also provides an informal settlement conference prior to the formal Administrative Hearing.

### SMALL BUSINESS BILL OF RIGHTS

In addition to the above listed rights, a Small Business is entitled to all of the rights established in A.R.S. §41-1001.01 and A.R.S. §41-1009 (A)(1)-(7), as well as A.R.S.
